Our product delivery policy has the benefit of no shipping charges and no state sales tax. Maryland's Comptroller's office has confirmed this to us in an email received we received on July 11, 2018:

"... Although Maryland law provides that the sale of photography that entitles the buyer to receive the product in a tangible format is a taxable sale of tangible personal property, Maryland has adopted the position that digital products delivered electronically where the buyer does not have the right to receive a tangible item is not a sale of tangible personal property. Therefore, the sale of a digital product that is only available by electronic download directly to the buyer's hardware is not taxable under current law."

MORE GOOD NEWS: YOUR SATISFACTION IS GUARANTEED

Your satisfaction is guaranteed. Hale Photo ServicesSM, LLC (HPS) will deliver high quality, state-of-the-art photographs and video. Although the technology has evolved at a startling pace, photography is still as much of an art as it is a science. Evaluating photographs and video is subjective by nature. As our client, your opinion and satisfaction is most important, but the final product will be the result of many factors – some of which are beyond the control of HPS. Weather, available light, condition of the subject property and physical limitations (e.g., room size, disrepair, junk in the yard, etc.) may be beyond our control and we can only make the best of what we find to photograph and record. It will not be our responsibility to have the clients' property looking as good as it can be. Property owners should be counseled about the need for "staging" and preparing for the photo shoot. Cleaning, painting, removing, packing away, picking up, de-personalizing, removing clutter and debris, landscaping and lawn maintenance and sprucing up in general will remain the responsibility of the property owners. All preparation should be completed to the clients' satisfaction before scheduling a photo shoot.

Typically, thirty to fifty photographs (depending on the property size and features) will be taken at each address for your selection and use in the multiple listing system and any other advertising or promotion you may want. Your choice of format available: JPEG, PNG, PDF, or TIFF. All photographs will be professionally "brightened and enhanced" as appropriate to showcase the subject property to its best advantage (without distorting reality or committing deception).

SCHEDULE CHANGES, DELAYS, and CANCELLATIONS

Stuff happens. Scheduled appointments may be changed with a minimum of four (4) hours' advance notice – otherwise, a cancellation/delay fee of \$50 (\$100 for drone jobs) will be charged. Weather delays may occur with rescheduling on a mutually agreeable basis without penalty. Cancellations with a minimum of four (4) hours' advance notice will result in a full refund of advance fees paid. With less than four (4) hours' advance notice, a cancellation fee of \$50 (\$100 for drone jobs) will be charged.

Area Served is generally a 30-40 mile radius from Westminster, Maryland that is roughly defined as the area bounded by I-70 to the south, I-81 to the west, Pennsylvania State Route 30 to the north, I-83 to the east, and I-695 to the southeast. Consideration will be given to locations outside this range with additional charges for time and expenses.

Unmanned Aerial Vehicles (UAV)

Home and Property

Property sellers are increasingly insisting on aerial photography. To continue to be competitive as a real estate professional, consideration must be given to this demand. It must be understood that the only way to fly a drone for commercial purposes, is by or under the direct supervision of an Unmanned Aerial System pilot – licensed by the Federal Aviation Administration (FAA). Without a license, a federal law is being broken.
